Re: Written Determination Pursuant to M.G.L. Chapter 91

Waterways License Application №: W16-4600 Weymouth Compressor Station, 6 & 50 Bridge Street, Weymouth Fore River DPA, Filled Tidelands of the Fore River, Weymouth, Norfolk County

Dear Mr. Child:

The Massachusetts Department of Environmental Protection (the "Department" or "MassDEP") hereby issues this Written Determination, pursuant to Massachusetts General Law (M.G.L.) Chapter 91 (c.91), the Public Waterfront Act, the Waterways Regulations at 310 CMR 9.00, and its intent to approve the referenced application subject to the attached conditions.

Algonquin Gas Transmission, LLC (the "Applicant") requests authorization pursuant to M.G.L. c.91 and applicable provisions of 310 CMR 9.00 to construct a natural gas compressor station located in the Weymouth Fore River Designated Port Area ("Weymouth Fore River DPA") on filled tidelands of the Fore River at 6 & 50 Bridge Street (Route 3A) Weymouth, Norfolk County (the "project site"). The total project site encompasses approximately 12.3-acres, of which approximately 9.8-acres (or 80% of the site) consists of previously authorized filled tidelands (8.1-acres of filled Private Tidelands and 1.7-acres of filled Commonwealth Tidelands), 0.4-acres (or 3% of the site) of flowed Commonwealth Tidelands, and 2.1-acres (or 17% of the site) of uplands located outside of c.91 jurisdiction.

The proposed project consists of a new natural gas compressor station (referred to as the "Weymouth Compressor Station") that will interconnect with Algonquin's existing I-10 natural gas pipeline system (referred to as the "HubLine" and authorized in Waterways License No. 9451 issued in 2002 as a water-dependent-industrial infrastructure crossing facility for the

transmission of natural gas) located on the western portion of the project site and assist in the overall pipeline capacity necessary to deliver natural gas supplies needed to meet supply and load growth requirements in the northeast market (referred to as the "Atlantic Bridge Project"). Specifically, the Weymouth Compressor Station will include two (2) new buildings: one (1) 5,800-square foot (56-foot 6-inches high) compressor building housing a 7,700-horsepower natural gas-fired compressor unit and one (1) 6,100-square foot (38-foot 6-inches high) auxiliary building housing offices for compressor station personnel, electrical motor control centers, control room, security system, garage bays, parts storage, compressed air system and an emergency generator.

The proposed project also includes 10-surface parking spaces, internal roadway circulation, underground utilities, and a 6,200-square foot stormwater basin which will connect to the existing onsite stormwater system and outfall structure, and the placement of 12,000-cubic yards of new fill on top of previously authorized filled tidelands in order to achieve a first floor building elevation above the 100-year flood zone and in order to make the site and buildings resilient to flooding and projected sea level rise over the project lifetime.

Although not part of the project site, the Applicant will be responsible for the future maintenance of a 3.9-acre perpetual public access easement on the abutting Conservation Restriction Area (which includes the 1-acre Lovell's Grove Parcel and 2.9-acre King's Cove Parcel) which provides point access from Bridge Street to King's Cove and the Fore River, in accordance with the terms and conditions of a Conservation Restriction executed for said area which was accepted by the Town of Weymouth Conservation Commission on August 15, 2007, approved by the Secretary of Energy and Environmental Affairs on February 2, 2009, and recorded at the Norfolk County Registry of Deeds in Book 26454, Page 446 on March 17, 2009.

Findings:

- 1) The Department determines that the approximately 12.3-acre site consists of 9.8-acres (or 80% of the site) of previously authorized filled tidelands (8.1-acres of filled Private Tidelands and 1.7-acres of filled Commonwealth Tidelands), 0.4-acres (or 3% of the site) of flowed Commonwealth Tidelands, and 2.1-acres (or 17% of site) of non-jurisdictional uplands. The Department's Presumptive Line Project delineated the historic high water line onsite based on a compilation of the United States Coast Survey Plan entitled "Quincy Bay" (Sheet 2) dated 1847 and the United States Coast and Geodetic Survey Plan entitled "Boston Harbor, Town Bay to Nantasket Beach" dated 1892. The Department's Presumptive Line Project also delineated the historic low water mark onsite based on United States Coast Survey Plan entitled "Quincy Bay" (Sheet 2), dated 1847.
- 2) The Department determines that the entire project site is located within the Weymouth Fore River Designated Port Area and therefore must comply with the applicable Waterways Regulations at 310 CMR 9.00.
- 3) The Department determines that the use of filled Private and Commonwealth Tidelands for said compressor station is considered an ancillary facility to a previously authorized

water-dependent-industrial infrastructure crossing facility for the transmission of natural gas (authorized in DEP Waterways License No. 9451 issued in 2002) and permissible within a Designated Port Area per 310 CMR 9.12(2)(d) and the Secretary's Certificate (EEA #12355) dated March 19, 2002.

- 4) The Department determines that the required Public Notice was published in The Patriot Ledger and in the Environmental Monitor on March 9, 2016 and re-noticed in The Patriot Ledger and in the Environmental Monitor on April 6, 2016 at the request of the Town of Weymouth to extend the public comment period to April 19, 2016. At the request of the Town of Weymouth, the Department also held a Public Hearing on March 28, 2016 at 5:30pm at the Abigail Adams Middle School Auditorium, 89 Middle Street, Weymouth. The Department received seventy-two (72) public comment letters (containing approximately 240 signatures) before or by the extended comment period deadline and sixteen (16) public comment letters after the extended comment period deadline. All written comments received by the Department were in opposition of said project. Chapter 91 related issues raised in the letters of opposition include, but were not limited to, questioning the water-dependency of said project, questioning the use of said project in a Designated Port Area, questioning whether said project meets the purpose statement in 310 CMR 9.01, and raising potential navigational and fishing impacts to the waterway as a result of said project. All comments received prior to the extended comment period deadline were reviewed and responded to satisfactorily by the Applicant or addressed by the Department in the Findings or Special Conditions of this decision.
- 5) The Applicant has submitted relevant documentation regarding other state and local approvals pursuant to 310 CMR 9.14(5) including: 1) Wetlands Protection Act—An Order of Conditions (DEP #81-1170) was originally denied by the Weymouth Conservation Commission on June 15, 2016 under both the Wetlands Protection Act (WPA) and a local by-law. The Department issued a Superseding Order of Conditions (SOOC) on September 7, 2016, approving the project under the WPA. The SOOC was subsequently appealed to the Department's Office of Appeals and Dispute Resolution, and the appeal was stayed until the Federal Energy Regulatory Commission (FERC) or a court of competent jurisdiction issues a decision regarding preemption of the denial under the local Wetlands Ordinance pursuant to the Natural Gas Act, 15 U.S.C. § 717 et. seq.; 2) A Municipal Planning Board Notification—The notification was signed by the Town of Weymouth Principal Planner on December 8, 2015; 3) Municipal Zoning Certification—The project has not received local zoning approval; 4) FERC Certificate— The Applicant has provided evidence that FERC issued a Certificate of Public Convenience and Necessity ("FERC Certificate") for the project on January 25, 2017.

The Final License will not be issued until the Department receives the local approvals specified in 310 CMR 9.11(3)(c)(3) or until a determination is made that such approvals are pre-empted under the Natural Gas Act. However, the Applicant has provided the information necessary to issue the Written Determination without documentation of all state and local approvals specified in 310 CMR 9.11(3)(c)(3). The FERC Certificate, noting that permits which "unreasonably delay the construction or operation of facilities

approved by [FERC]" may be inconsistent with the Natural Gas Act, constitutes under 310 CMR 9.11(3)(c)(3)(d) a "satisfactory explanation as to why it is appropriate to postpone receipt of such documentation to a later time prior to license or permit issuance".

- 6) The Department has determined that the compressor station buildings have been designed to meet the Engineering and Construction Standards at 310 CMR 9.37(1) and addresses sea level rise, as required by 310 CMR 9.37(2)(b), as the elevation of the first habitable floors of said buildings will be at 19.5-feet NAVD88, which is 9.5-feet above the 100-year AE Flood Zone (which has a determined base flood elevation of 10-feet NAVD88).
- 7) The Department presumes that the project serves a proper public purpose in accordance with 310 CMR 9.31(2)(a).
- 8) The Department presumes that the proposed project is consistent with all applicable Coastal Zone Management (CZM) policies, in accordance with M.G.L. c.91 § 18 and 310 CMR 9.13(2)(a).

Conclusion:

On the basis of the foregoing analysis, the Department will approve the proposed structures and uses described herein, as shown on the draft license plans and as shall be modified and delineated on the final license plans in accordance with the terms of this Determination. This Determination is subject to the attached Special Conditions to be carried out by the referenced Applicant (hereinafter the "Licensee"). These Special Conditions will be included, in substantially the same form, along with the Standard Conditions, with the final Chapter 91 Waterways License to be issued pursuant hereto. This Determination, including the attached Special Conditions, is subject to appeal as described in more detail in the Notice of Appeal Rights section on Pages 10 and 11. The Department will grant the Chapter 91 Waterways License if no appeals are filed within twenty-one (21) days of the issuance of this Determination and upon receipt of the final mylar license plans.

No construction or alteration in or to any portion of the site within jurisdiction pursuant to M.G.L. c.91 is authorized until a Waterways License has been issued. If you have any further questions, please contact Frank Taormina, Waterways Regulation Program, at (617) 292-5551.

NOTICE OF APPEAL RIGHTS

Who has the right to appeal?

The following persons shall have the right to an adjudicatory hearing concerning this decision by the Department to grant or deny a license or permit, in accordance with 310 CMR 9.17(1): (a) an applicant who has demonstrated property rights in the lands in question, or which is a public agency; (b) any person aggrieved by the decision of the Department to grant a license or permit who has submitted written comments within the public comment period; (c) ten (10) residents of the Commonwealth who, pursuant to M.G.L. Chapter 30A, § 10A, have submitted comments within the public comment period with at least 5 of the 10 residents residing in the municipality(s) in which the license or permitted activity is located. The appeal shall clearly and specifically state the facts and grounds for the appeal and the relief sought, and each appealing resident shall file an affidavit stating the intent to be part of the group and to be represented by its authorized representative; (d) the municipal official in the affected municipality who has submitted written comments within the public comment period; and (e) CZM, for any project identified in 310 CMR 9.13(2)(a) for CZM participation or, in an Ocean Sanctuary, if it has filed a notice of participation within the public comment period.

How can I request an adjudicatory hearing?

A person requesting an adjudicatory hearing must submit a "Notice of Claim" to the Department, with a copy of the MassDEP Adjudicatory Hearing Fee Transmittal Form and include the details specified below, within twenty-one (21) days of the date of issuance of this decision. What information must be included in the hearing request?

Pursuant to 310 CMR 9.17(3), any Notice of Claim requesting an adjudicatory hearing <u>must include the following information</u>:

- (a) the MassDEP Waterways Application File Number;
- (b) the complete name, address, fax number and telephone number of the Applicant;
- (c) the address of the project;
- (d) the complete name, address, fax number, and telephone number of the party filing the request and, if represented by counsel, the name, address, fax number, and phone number of the attorney;
- (e) if claiming to be a person aggrieved, the specific facts that demonstrate that the party satisfies the definition of "aggrieved person" found in 310 CMR 9.02;
- (f) a clear statement that a formal adjudicatory hearing is being requested;
- (g) a clear statement of the facts which are the grounds for the proceedings, the specific objections to the MassDEP's written decision, and the relief sought through the adjudicatory hearing, including specifically the changes desired in the final written decision; and
- (h) a statement that a copy of the request has been sent to: the Applicant and the municipal official of the city or town where the project is located.

Dismissal of request

The request for appeal will be dismissed if the filing fee is not paid, unless the appellant is exempt or is granted a waiver.

Exemptions

The filing fee is not required if the appellant is a city or town (or municipal agency), county, or district of the Commonwealth of Massachusetts, or a municipal housing authority.

Waiver

The Department may waive the adjudicatory hearing filing fee pursuant to 310 CMR 4.06(2) for a person who shows that paying the fee will create an undue financial hardship. A person seeking a waiver must file an affidavit setting forth the facts believed to support the claim of undue financial hardship together with the hearing request as provided above.



Any change in use or any substantial structural alteration of any structure or fill authorized herein shall require the issuance by the Department of a new Waterways License in accordance with the provisions and procedures established in Chapter 91 of the Massachusetts General Laws. Any unauthorized substantial change in use or unauthorized substantial structural alteration of any structure or fill authorized herein shall render this License void.
- 4. This Waterways License shall be revocable by the Department for non-compliance with the terms and conditions set forth herein. This License may be revoked after the Department has given written notice of the alleged non-compliance to the Licensee and those persons who have filed a written request for such notice with the Department and afforded them a reasonable opportunity to correct said non-compliance.
